- 7. Copy of all Prescriptions.
- 8. Copy of all Investigation Reports (if claimed) from empanelled Hospital/Diagnostic Center.
- 9. Detailed List with break-up of Miscellaneous Items.
- 10. Properly filled Annexure- I(for OPD) with official Seal of the Hospital, Date, Signature of the Doctor and other mandatory details (original)
- 11. Properly filled Annexure- II for IPD (if non empanelled Hospital)
- 12. Copy of WBHS certificate
- 13. Audiometry Report in case of buying Hearing Aid (original).
- 14. Condone letter with valid reason if the submission has taken place after 6 months (vide order no. 67-F(MED)WB dated25/06/2020)
